Sub: Disclosure of Order passed by Appellate Tribunal for Electricity (APTEL)

We refer to our letter dt.22.08.2023 filed with Stock Exchanges, wherein we have disclosed the details of pending litigations or disputes which may have an impact on the company.

In furtherance to the above, we wish to inform that the Appellate Tribunal for Electricity (APTEL) has delivered its judgement on 16.06.2025 in our favour on the levy of Parallel Operation Charges (POC).

Development in proceedings	<p>APTEL vide its order dated 16.06.2025 passed in batch of appeals including our appeal, has set aside TNERC order dated 04.01.2019.</p> <p>APTEL held that parallel operation charges envisaged under Regulation 26 of Open Access Regulations, 2014 are leviable from only those captive generating plants who opt for parallel operation with the grid by submitting requisite application in this regard along with requisite fee as per the procedure prescribed under Regulation 5 of these Regulations.</p>
Expected financial implications, if any	Aggregate provision of about Rs.4.95 crores (including demand and further accruals) till March 2025 would get reversed in Q1 of FY 2025-26.
